WELL WORK PLUGGING PERMIT

Plugging

This permit, API Well Number: 47-100584, issued to PDC MOUNTAINEER LLC, is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to all conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. The above named operator will also file, as required in WV Code 22-6-23, an affidavit on form WR-38 by two experienced persons in the operator's employment and the Oil and Gas inspector that the work authorized under this permit was performed and a description given. Failure to abide by all statutory and regulatory provisions governing all duties and operations here under may result in suspensions or revocation of this permit and in addition may result in civil and/or criminal penalities being imposed upon the operator.

PERMIT CONDITIONS

West Virginia Code § 22-6-11 allows the Office of Oil and Gas to place specific conditions upon this permit. Permit conditions have the same effect as law. Failure to adhere to the specified permit conditions may result in enforcement action.

CONDITIONS

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.
- 4. This well is under a consent order and must be plugged within two years of the date of issuance of this permit.

The 4 ½" casing appears to have been cemented with 175 sacks of cement. If this was Class A cement, then the likely TOC would be about 3700' and a casing cut could be made just above this depth. You would then be able to remove ~ 3700' of 4 ½" casing and set a 100' C1A cement plug across the cut (3750' to 3650'). Set a plug of 100' C1A cement from 1660' to 1560'. Set C1A cement plug from 1258' to 1158' (elevation). Make sure that all space between cement plugs is filled with gel. Gel by definition is fresh water with at least 6% bentonite (by weight) and no other additives.

* At this point make the well bore available to Coalquest (Arch) Operations for electric logging purposes.

When plugging operations start back check for freepoint of 8 5/8" casing. Please keep in mind that the Office of Oil & Gas has provided additional records to you that indicate that the 8 5/8" casing was cemented to surface. If this is the case, you would not be required by the OO & G to remove the 8 5/8" casing.

Run in the hole with a work string to add a cement plug from the top of the last plug (1158') to 655'. Wait 4 hours and check the TOC. Add more cement if needed. Gel hole to 100' and set C1A cement plug from 100' to surface. Install monument per WV State Code. (35-4-5.5b)

All plugs must be at least 100' in length and consist of Class A Cement with no more than 3% Calcium Chloride and no other additives.

All casing cuts must have a minimum of 100' Class A Cement plug set across the cut.

Gel consists of fresh water with a minimum of 6% bentonite (by weight) and no other additives.

The entire wellbore must be filled with either gel or cement plugs.
