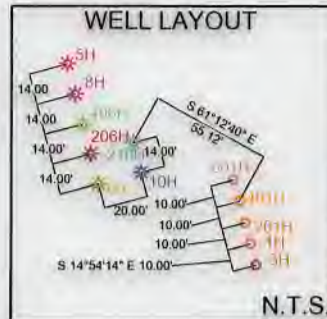


EXISTING WELLS
