Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Well detail:

The Office of Oil and Gas does have a well record for the subject well (47-015-00641). The record shows well TD at 1773'. There is 23' of 13" conductor casing, 230' of 10" casing and 1773' of 4-1/2" casing. The record shows 4-1/2" casing cemented back to surface. The 4-1/2" casing was perforated from 1636' to 1668'. The record shows fresh water at 277' and 307'. Coal at 190'. No salt water recored. Well site elevation is 886'.

Site-based considerations:

The well site is flat and covered in grass and brush. The well site will need to be cleared. All brush can be piled and left on location. There is no storage tank located at the well site. There is production equipment at the well site that will be removed. The well is currently shut in. The well is leaking gas and oil at the surface. OOG will contact locate 811 to mark all sub surface utilities.

The work order for the manner of plugging this well is as follows:

- Notify inspector specialist, Allen Flowers @ (304) 552-8308.
 Email address is Allen.D.Flowers@wv.gov, Notification is required 24 hrs prior to commencing plugging operations.
- 2. Move in and rig up to existing 4-1/2" inch casing.
- 3. TIH pull rods, tubing and packer if found.
- 4. TIH check TD @ or below 1773'. If TD cannot be reached begin cleaning out hole to approved depth/TD by inspector.
- 5. Once TD has be reached and approved by inspector a bond log will be ran inside the 4-1/2" casing to determine cement bond location and free points. Any casing found with out cement in the annulus that cannot be retrieved must be perforated at all required locations.
- TIH to TD with tubing, spot 6% gel followed by cement from TD' to 1500'. TOH, WOC tag top of plug. Add cement if needed.
- 7. TIH with tubing, spot 6 % gel from 1500' to 950', followed by cement plug From 950' to 700'. TOH, WOC tag top of plug. Add cement if needed.
- 8. TIH with tubing, spot 6% gel from 700' to 300', followed by cement plug From 300' to surface.
- Rig down and install monument, reclaim site.
 NOTE.. Any casing found in the well with out cement in the annulus that

Cannot be retrieved must be perforated and cemented at all saltwater, Freshwater, coal, gas, casing shoe and elevation points.

Records held by the Office of Oil and Gas (OOG) indicate that you are the landowner of a parcel located along the Elk River Procious, WV further identified on tax forms as Parcel ID: 08-06-0010-0011-0000. Our records additionally show that well API Numbers 47-015-00027,47-015-00614,47-015-00641,47-015-00646 and 47-015-00658 are located on that property. Based on the abandoned well inspections dated August 21, 2023 (see enclosed), these wells are considered a potential hazard or imminent danger, a possible pollutant to the surface or underground, or is wasting natural resources (leaking) and must be properly plugged or cleaned out and re-plugged.

Pursuant to W. Va. Code § 22-6-29, and under the direction and supervision of West Virginia Department of Environmental Protection, a contractor for the State of West Virginia will enter onto the property, properly plug the above named well at no cost to you. Further, the state will remove all associated materials from the well location and reclaim, seed, and mulch the well location and well road accesses used, to state specifications.

Please sign and return the enclosed form, WW-4D, affirming that you have no objection to the State of West Virginia having a responsible contractor enter upon or traverse your property for the purpose of plugging this well. REPORT OF THE OFFICE

In response to industry requests, the West Virginia Department of Environmental Protection, Office of Oil and Gas has reviewed the proposed use of American Petroleum Institute (API) Class L cement to be used in place of API Class A cement for well plugging.

FINDINGS OF FACT

- On July 28, 2022, Diversified Gas & Oil Co. (DGO) submitted a variance request from Legislative Rule 35CSR4 for the use of API Class L cement in place of API Class A cement, relating to the plugging of conventional wells.
- Laboratory analysis submitted by DGO on July 28, 2022, indicates API Class L cement is comparable to API Class A cement and thereby satisfies the requirements of the West Virginia Code.
- 3. Contemporaneously, the Chief of the Office of Oil and Gas also chose to consider a variance to Legislative Rule 35CSR8 Section 20.1., for the use of API Class L cement in place of API Class A cement, relating to the plugging of horizontal wells.

Promoting a healthy environment.

 On August 18, 2022, the Office of Oil and Gas provided public notice of acceptance of public comments on the variance consideration. During the 20-day public comment period, no comments were received.

CONCLUSIONS OF LAW

Pursuant to Article 6 and Article 6A, Chapter 22 of the Code of West Virginia, the Office of Oil and Gas has jurisdiction over the subject matter, and the persons interested therein, and jurisdiction to promulgate the hereinafter prescribed Order.

Pursuant to Legislative Rule 35CSR4, Section 18 and Legislative Rule 35CSR8, Section 14, the Chief of the Office of Oil and Gas may grant a variance from any requirement of these rules.

ORDER

It is ordered that the Class L cement product approved and monogramed by API is approved for use in place of API Class A cement for well plugging subject to the provisions of Legislative Rule 35CSR4 and Legislative Rule 35CSR8.






