





These two wells were submitted to your office, after further research and information from WV DOH, it was found that the access road that people use to access this area is not a county road but an MNS road. So SLS did a new Rec. Plan that showed the road coming off of County Route 4/6 where the WV DOH says it ends. I sent a copy of this Rec.
