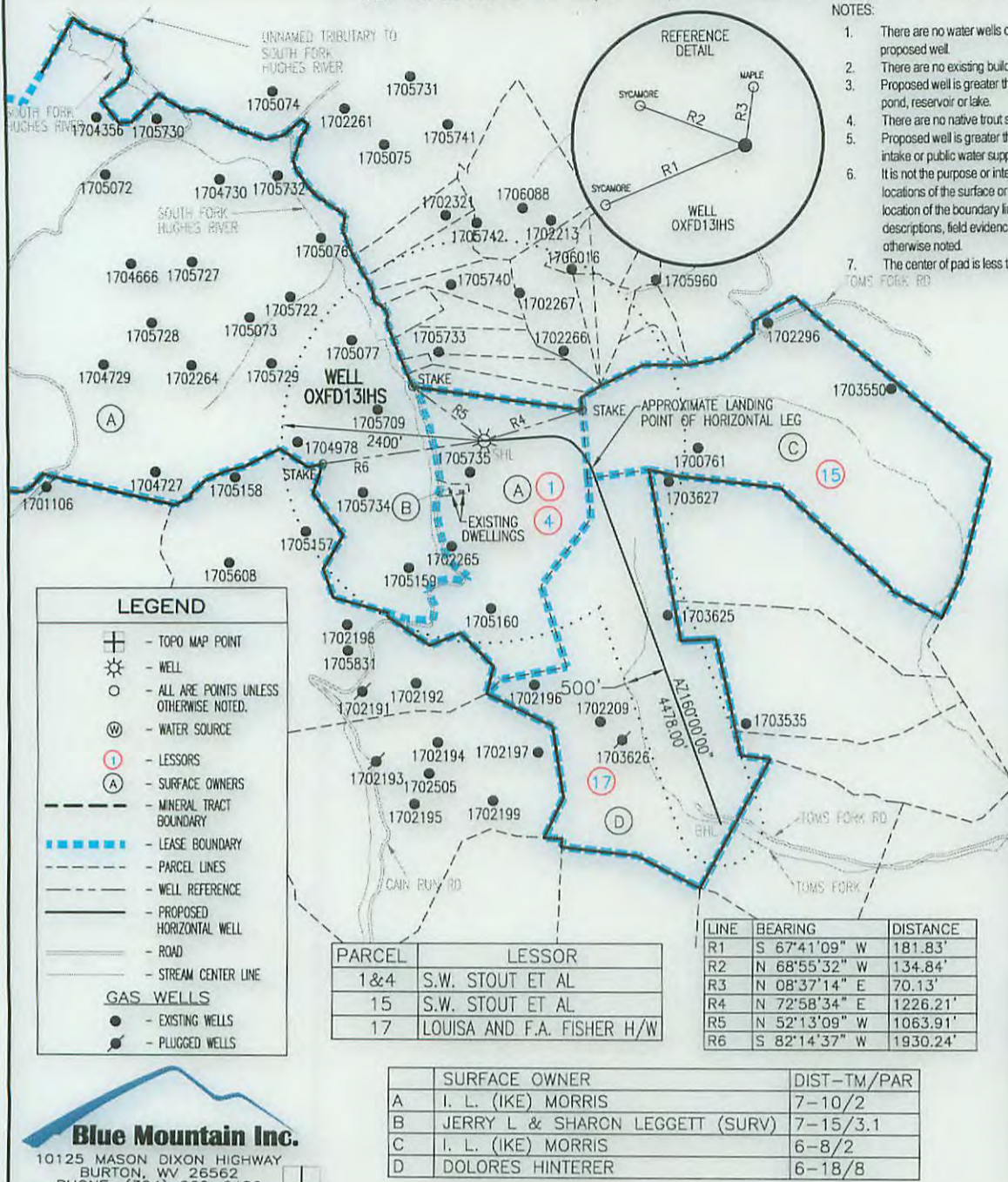

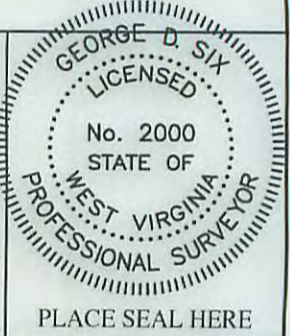

This submittal is intended to satisfy your request for updated plats to the above referenced well permits. As you are aware, CNX Gas Company LLC received approved modifications to the OXFD13FHS and OXFD13IHS permits on 06/01/2015 allowing for a directional (NW to SE) and formation (Burket to Marcellus) drilling change. As was discussed at the time, the modification was to intended utilize the originally permitted surface hole location for each well in order to accomplish the desired directional and formational change.

Upon completion of the as-drilled plats, it has come to our attention that the plats used to modify the referenced well permits show incorrect surface hole location coordinates. Therefore, enclosed for your review and the Department's well file are copies of corrected plats show the originally permitted surface locations that were used to develop these wells.


