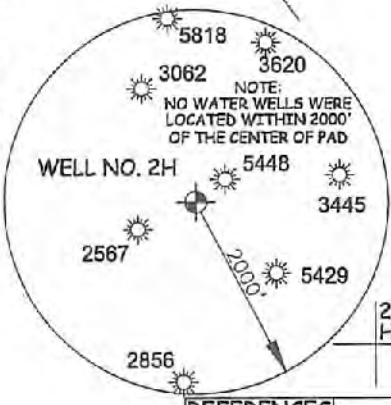
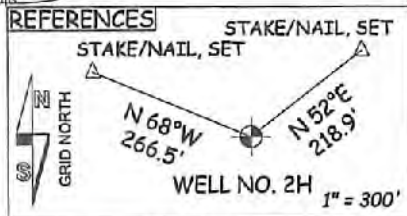
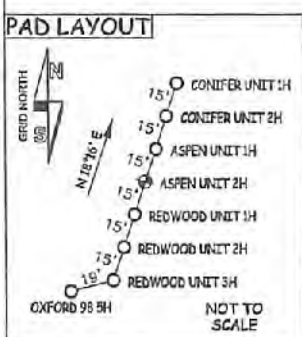


NOTES

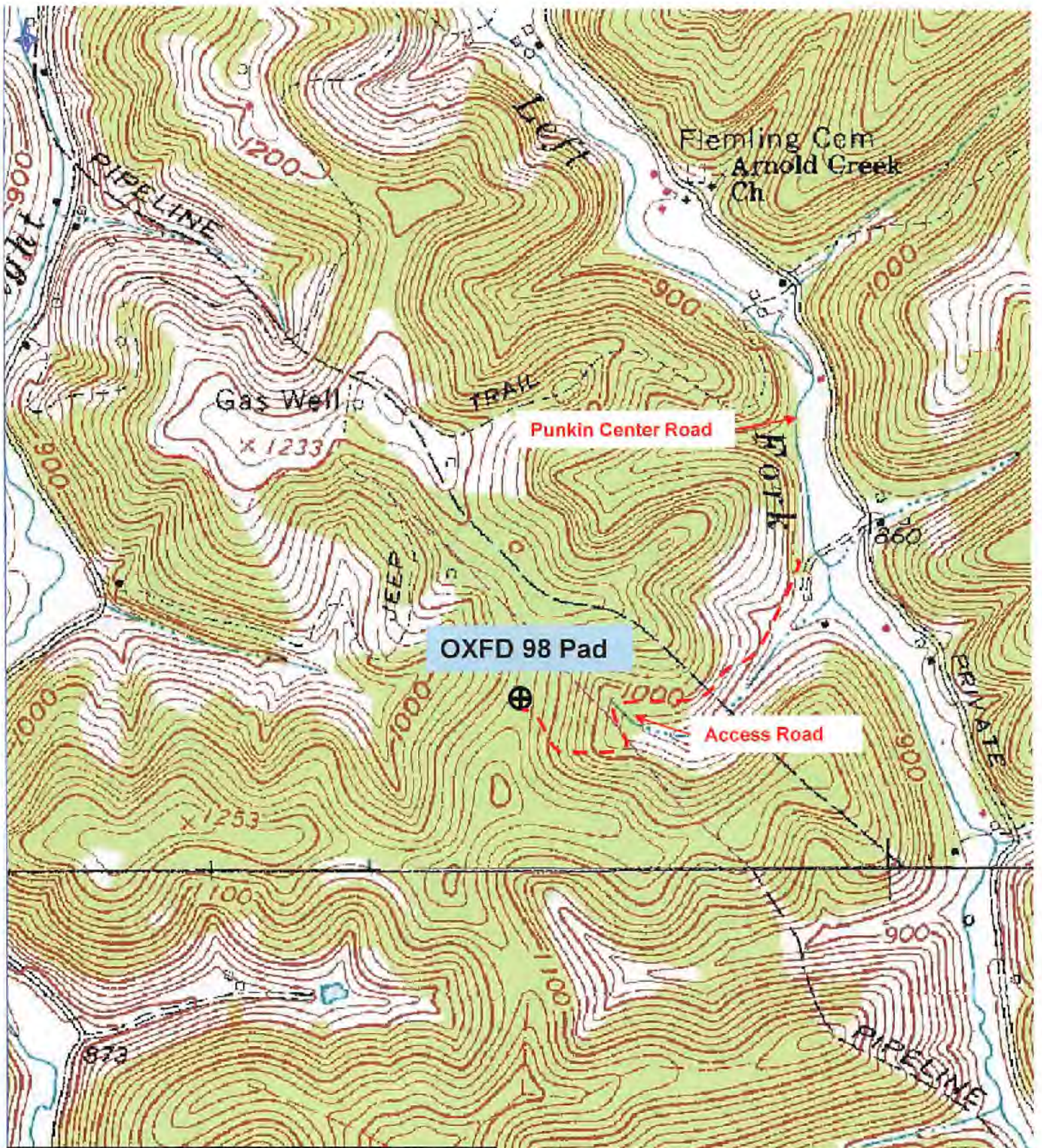
