Please find attached the plugging prognosis modification for the API# 4701900574 S-599 in Fayette County, WV.

The changes made are:

- Added 50' of cement to the bottom completion plug bottom at 2780' instead of 2730'
- Added in running a CBL on the 4-1/2" to verify TOC. We don't know what size hole they
 drilled for the production string so need to verify TOC to know if we need to cut and pull
 any 4-1/2" casing
