

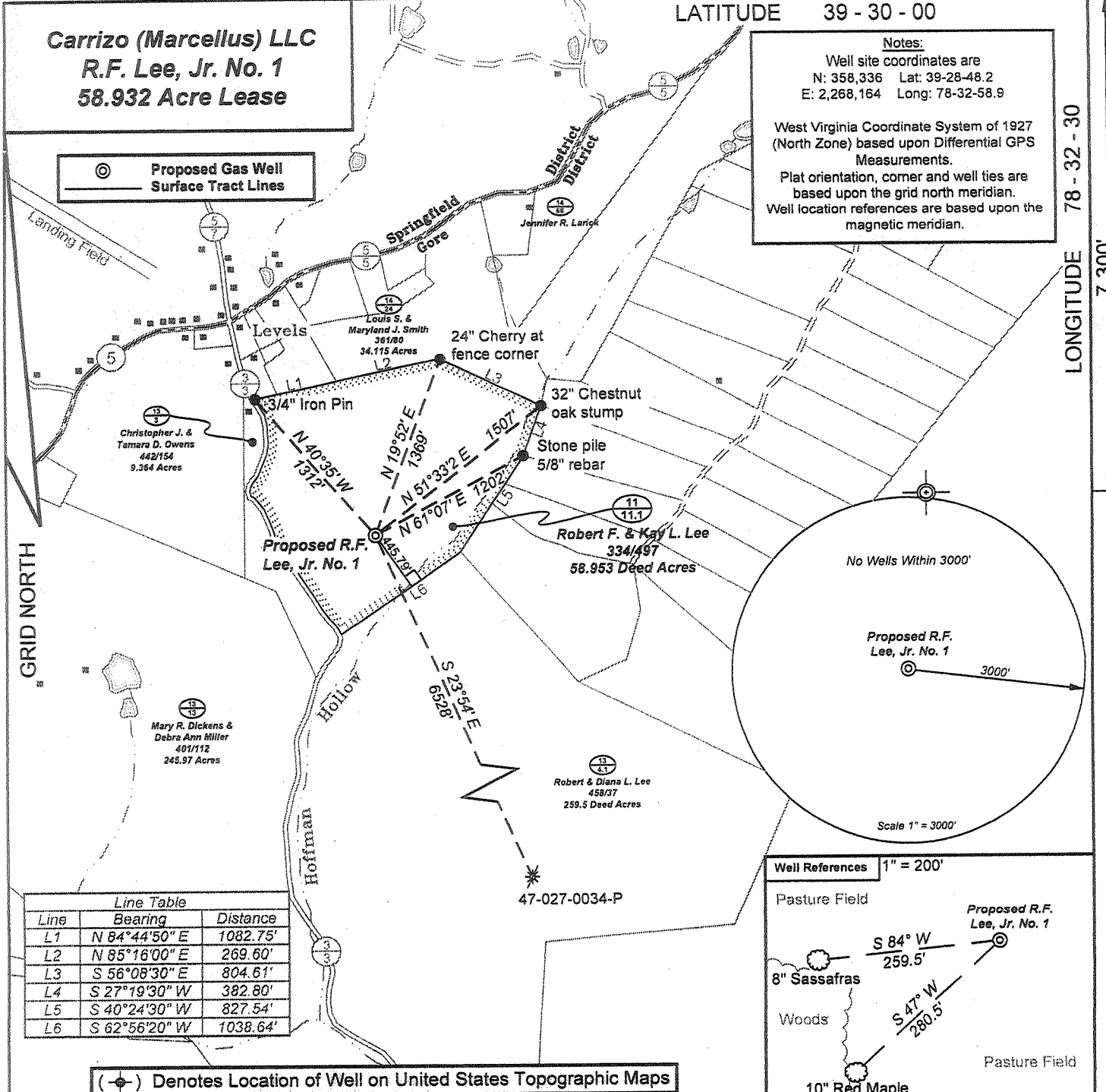

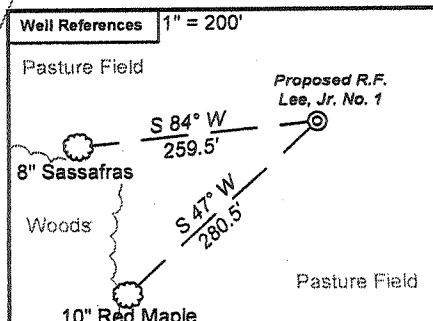
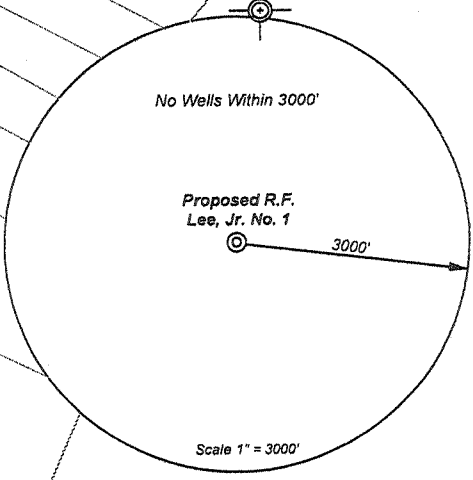
**Proposed Gas Well

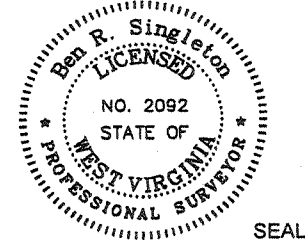

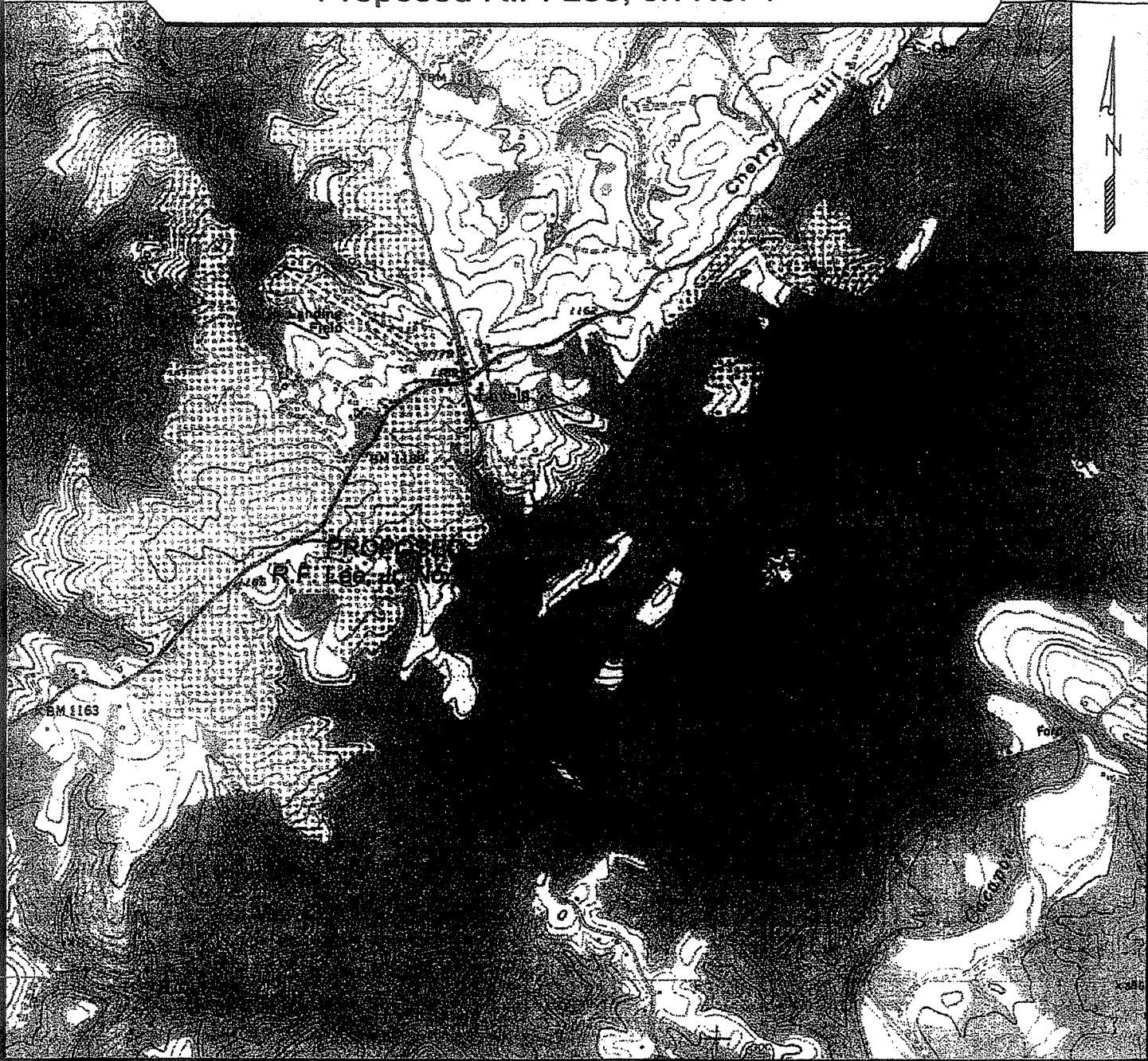
