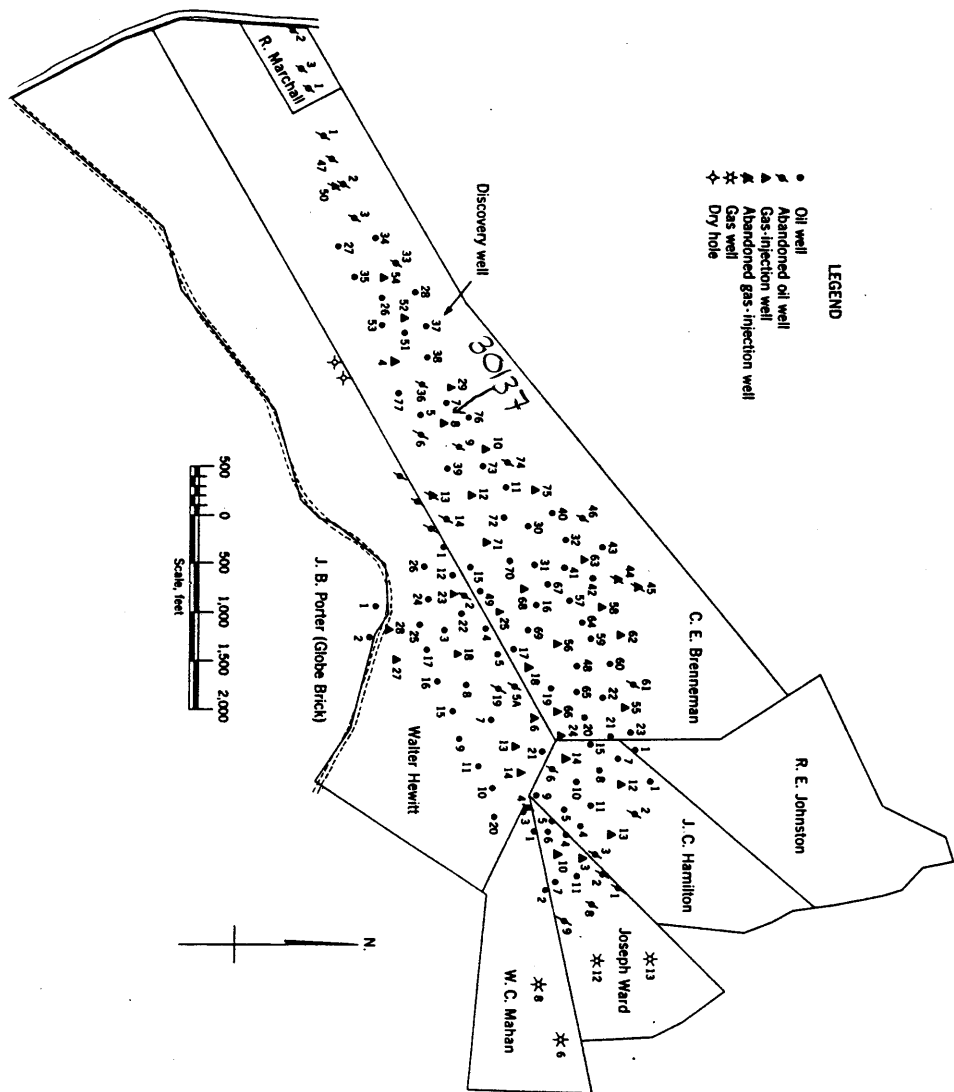


Figure 1. - Ownership map of Brenneman field, Hancock County, W. Va., showing location and status of wells on December 31, 1948.

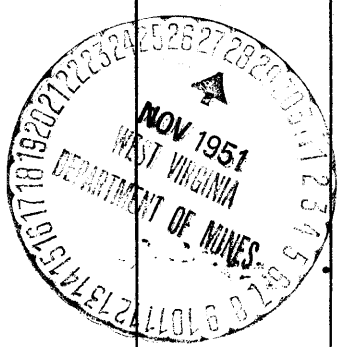
