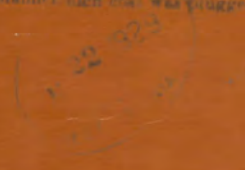
AFFIDAVIT

I, Wm Chambers and Ernest D. Dodd  
being first sworn according to law depose and say that they are experienced in the work of plugging  
and filling oil gas wells and were employed by Mary C. Thompson well operator,  
and participate the work of plugging and filling the above well that said work was commenced on the  
21st day of August 1929 and that the well was plugged and filled in

Manner which sand was plugged. Filled with Red Clay from 1930' to 1770'.  
Cement Plugged at 1770'. Bridged hole at 1744 and filled with Red Clay to  
1700'. Dr 6" Wood Plug at 1700'. Filled with Red Clay to 1680'. Plugged  
Cement Plug 1680'. Bridged hole at 1345' and filled with Red Clay to  
1214'. Dr 6" Lead Plug at 1214' placed Cement Plug on top of lead plug.  
Filled with Clay to 520' and drove 6" Wood Plug. Filled with Red Clay  
to 280'. Washer for Bliss Shut-Off Valve at 309' - Cement Plug placed at  
209' also. See Shut-Off Valve set at 141'. Cement Plug placed at 141'.  
Hole filled top with Red Clay - Monument placed at top of hole.  
Manner each well was plugged
