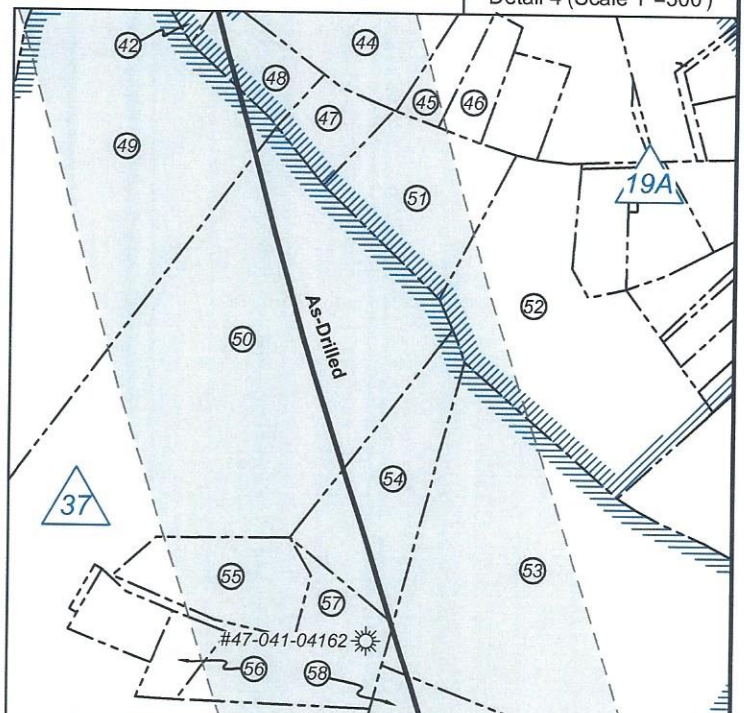

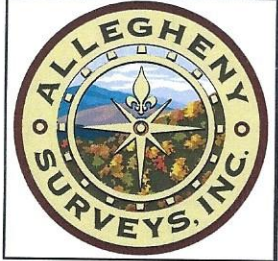

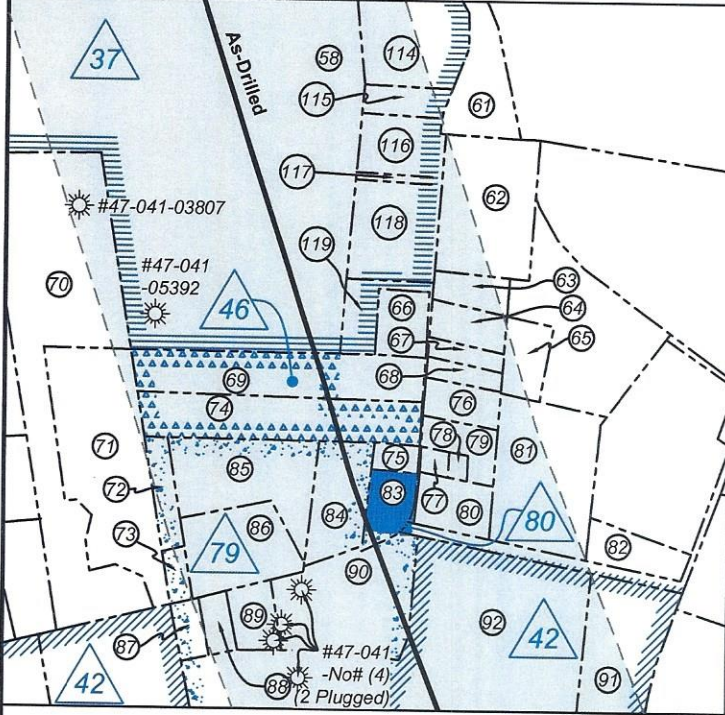

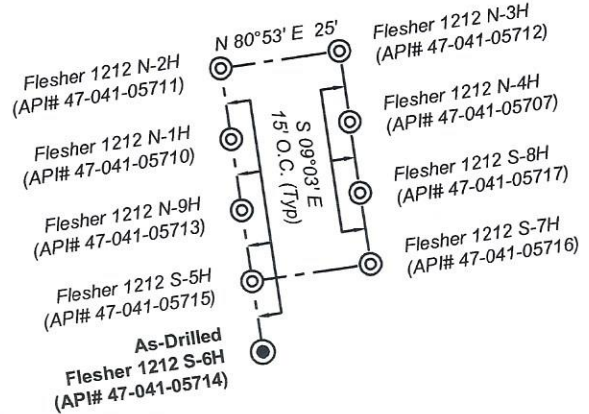

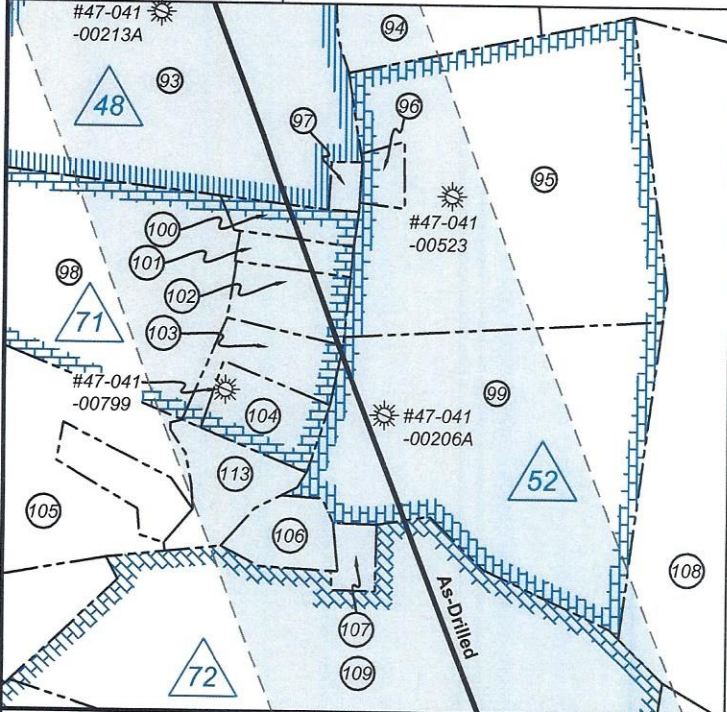
Detail 5 (Scale 1"=500')



Wellhead Layout (NTS)



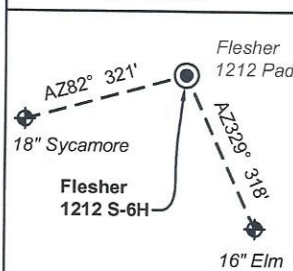
