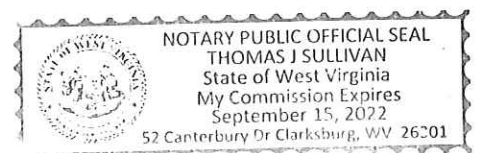

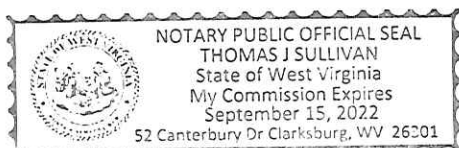

Matthew Yearsley and Kevin S. Wright being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 10<sup>th</sup> day of December, 2021 and that the well was plugged in the following manner:

Sand or Zone Record Formation	Filling Material	Casing/Tubing Size	Casing Pulled	Casing Left In
	Cleaned a 12 1/4" hole from the surface to 210'. Reduced the hole to 9 7/8" at 210'. Cleaned a 9 7/8" hole from 210' to 1310'. Tagged the top of the existing 7" casing at 1310'. Reduced the hole to 6 1/4" at 1310'. Cleaned a 6 1/4" hole from 1310' to 1406'. Attempted to remove the existing 7" casing by pulling 150% of the string weight but all attempts were unsuccessful. Left an unknown amount of 7" casing in the hole from 1310' to an unknown depth. Cut remaining 7" casing at 1370.5' and 1320.5'. The 7" casing was previously ripped from 1346' to 1342', 1331' to 1327' and from 1316' to 1310'. Cleaned a 9 7/8" hole through the Pittsburgh Coal Seam (1164.5' to 1170.5'). Left 20' of 16" conductor in the hole from the surface to 20'.	7" Casing 16" Conductor	0' 0'	Unknown 20'
<b>Cemented the hole from 1406' back to the surface as follows:</b>				
From 1406' to 987' with 235 sacks of Thixotropic Cement with Green Dye and a Gas Blocker additive. Tagged the top of Thixotropic cement plug at 987'. Cemented the hole from 987' to 964' with 17 sacks Thixotropic and from 964' to the surface with 520 sacks of Expandable Cement. Cement did circulate at surface. A total of 772 sacks of cement were used to fill the hole from 1406' to the surface.
