WRIGHT** being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 6<sup>th</sup> day of December, 2011 and that the well was plugged in the following manner:

<b>Cemented hole from 1342' back to surface as follows:</b> From 1342' to 1136' with Expandable Cement . From 1136' to 829' with 170 sacks of Thixotropic Cement with green dye. From 829' to surface with Expandable Cement. A total of 620 sacks of cement were used to fill the hole from 1342' to surface. Cement did circulate at the surface.

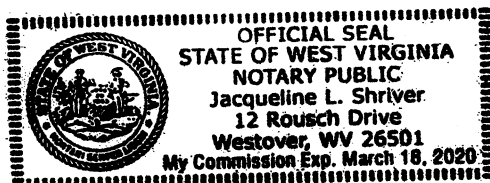
