DELBERT MOORE and KEVIN WRIGHT being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 16th day of October, 2012 and that the well was plugged in the following manner:

Cleaned 12 1/4" hole from the surface to 250'. Reduced hole to 9 7/8". Cleaned 9 7/8" hole from 250' to 775'. Reduced hole to 6 1/4". Cleaned 6 1/4" hole from 775' to 1312'. Tagged plug at 1312'. Cleaned 6 1/2" hole through Pittsburgh Coal (973' - 981'). Left 20' of 16" conductor pipe in the hole from 20' to surface.		16" Conductor	0'	20'
Cemented hole from 1312' back to surface as follows: From 1312' to 1181' with 63 sacks of Super Lite Cement. From 1181' to 873' with 124 sacks of SuperTropic Cement with white dye. From 873' to surface with 370 sacks of Super Lite Cement. A total of 557 sacks of cement were used to fill the hole from 1312' back to surface. Cement did circulate at the surface.

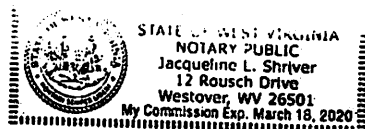
