DELBERT MOORE and KEVIN WRIGHT being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 28th day of December, 2012 and that the well was plugged in the following manner:

Cleaned 12 1/4" hole from the surface to 205'. Reduced hole to 9 7/8". Cleaned 9 7/8" hole from 205' to 1076'. Reduced hole to 7 7/8". Cleaned 7 7/8" hole from 1076' to 1079'. Reduced hole to 6 1/4". Cleaned 6 1/4" hole from 1079' to 1084'. Tagged solid plug at 1084'. Cleaned 9 7/8" hole through the Pittsburgh Coal seam from 755' to 764'. Left 20' of 16" conductor casing in the hole from the surface to 20'.		16" Conductor	0'	20'
<p><u>Cemented hole from 1084' back to surface as follows:</u> From 1084' to 655' 124 sacks of Super Tropic Cement with white dye. From 655' to surface with 364 sacks of SuperLite Cement. A total of 488 sacks of cement were used to fill the hole from 1084' back to surface. Cement did circulate at the surface.</p>
