MIKE MITCHELL and **KEVIN S. WRIGHT** being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Company well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 30th day of May, 2013 and that the well was plugged in the following manner:

Formation	Filling Material	Casing Size & Kind	Casing Pulled	Casing Left In
Cleaned 12 1/2" hole from the surface to 289'. Reduced hole to 9 7/8". Cleaned 9 7/8" hole from 289' to 1344'. Reduced hole to 7 7/8". Cleaned 7 7/8" hole from 1344' to 1380'. Reduced hole to 6 1/2". Cleaned 6 1/2" hole from 1380' to 1382'. Cleaned 9 7/8" hole through the Pittsburgh Coal seam from 853' to 862'.		16" Conductor	0'	30'
Cemented hole from 1382' back to surface as follows: From 1382' to 1062' with 125 sacks of 35/65 Poz Mix Cement. From 1062' to 753' with 132 sacks of Thixotropic Cement w/ dye. From 753' to surface with 264 sacks of Econofill Cement. A total of 521 sacks of cement was used to cement the hole from 1382' to surface. Cement did circulate at the surface. Left 30' of 16" conductor casing in the hole from the surface to 30'.


