This well work permit is evidence of permission granted to perform the specified well work at the location described on the attached pages and located on the attached plat, subject to the provisions of Chapter 22 of the West Virginia Code of 1931, as amended, and all rules and regulations promulgated thereunder, and to any additional specific conditions and provisions outlined in the pages attached hereto. Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Upon completion of the plugging well work, the above named operator will reclaim the site according to the provisions of WV Code 22-6-30. Please be advised that form WR-38, Affidavit of Plugging and Filling Well, is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

Per 35 CSR 4-5.2.g this permit will expire in two (2) years from the issue date unless permitted well work is commenced. If there are any questions, please feel free to contact me at (304) 926-0450.


CONDITIONS

- 3. Well work activities shall not constitute a hazard to the safety of persons.

- 1 Obtain NRP clearances, TOPs, pipeline crossing eval, etc.
- 2 Obtain State plugging permit.
- 3 Notify Reservoir Engineering & Geosciences (REG) of intent to take well out of service.
- 4 Prepare access road and well site. Install ECD's per EM&CP.
- 5 Service all wellhead valves.
- 6 Document initial tubing / casing / annular pressures.
- 7 Kill well. Load 7" casing and 7" x 8-5/8" annulus with kill fluid.
- 8 MIRU service rig.
- 9 NU 2000 # 7-1/16" BOPs (double ram with blind & pipe + annular). Secure BOPs to eliminate free movement.
 - Pressure test low/high to 250/1600 psig using packer set <30 ft. Pressure test TIW/stabbing valves.
- MIRU Baker Atlas and obtain CBL from TD to surface keep hole full while logging. Notify WET engineer for CBL evaluation procedure may change depending on results.

Consult with WE&T Engineer on results of CBL. Procedure may change depending on evaluation.


- 11 TIH with steel tooth bit. Clean to hard TD. Note that PBTD is at 1902' with cement plug, original TD of 2952'.
- 12 Circulate two bottoms up.
- 13 Spot balanced cement plug(s) from TD to 1600 ft. Note: Pull slowly through cement plug to cement top. Circulate. WOC minimum 6 hrs, tag cement. If cement top is deeper than 1750', install second cement plug.
- 14 Install cast-iron DBP above cement plug.
 - * Well to be plugged per 22-6-24 of the WV Code. Consult with State Inspector and WE&T Engineer to confirm the following procedure is still acceptable. If coal operator and TCE agree, the following procedure may require modifications.
- 15 TIH and install balanced cement plug from DBP to 1400' (~100' below depth of 8-5/8" csg shoe).
- 16 Install balanced expanding-type cement plug from top of last plug to 1200'. Gypsum is often used as an additive to provide expansion properties or to prevent cement shrinkage. Before TOOH spot 6% bentonite gel from top of plug to approximately 100' below surface.
- 17 WOC and tag cmt. If solid cement top is deeper than 1200' then consult with State inspector or reinstall plug.
- 18 Install 100' cement plug inside 7" casing at top of well.
- 19 Top of all annuli with cement.
- 20 ND BOPs and remove wellhead.
- 21 RDMO service rig.
- 22 Install monument a minimum of 30" above ground level with no smaller than 6" OD steel pipe. Tack weld API number to side of monument. Tack weld, do not seal, a steel plate on top of monument.
- 23 When plugging is complete, install plastic Columbia Gas line marker next to monument.
- 24 Reclaim road and location.


