

being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by Consolidation Coal Co. well operator, and participated in the work of plugging and filling the above well, that said work was commenced on the 9th day of June 2000 and that the well was plugged in the following manner:

Trip in hole with 4 ¾" bit inside 5 ½" casing. Set down at 1077'. Drilling on hard cement from 1077' to 1103'. Pulled 5 ½" casing and 8" casing together to 449'. Trip in hole with 10 ¾" pressure cutter and cut 10 ¾" casing every 6" thru coal seam from 383 ½' to 390'. Cement back from 1103' to surface with solid cement plug. 
