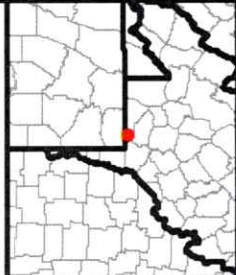

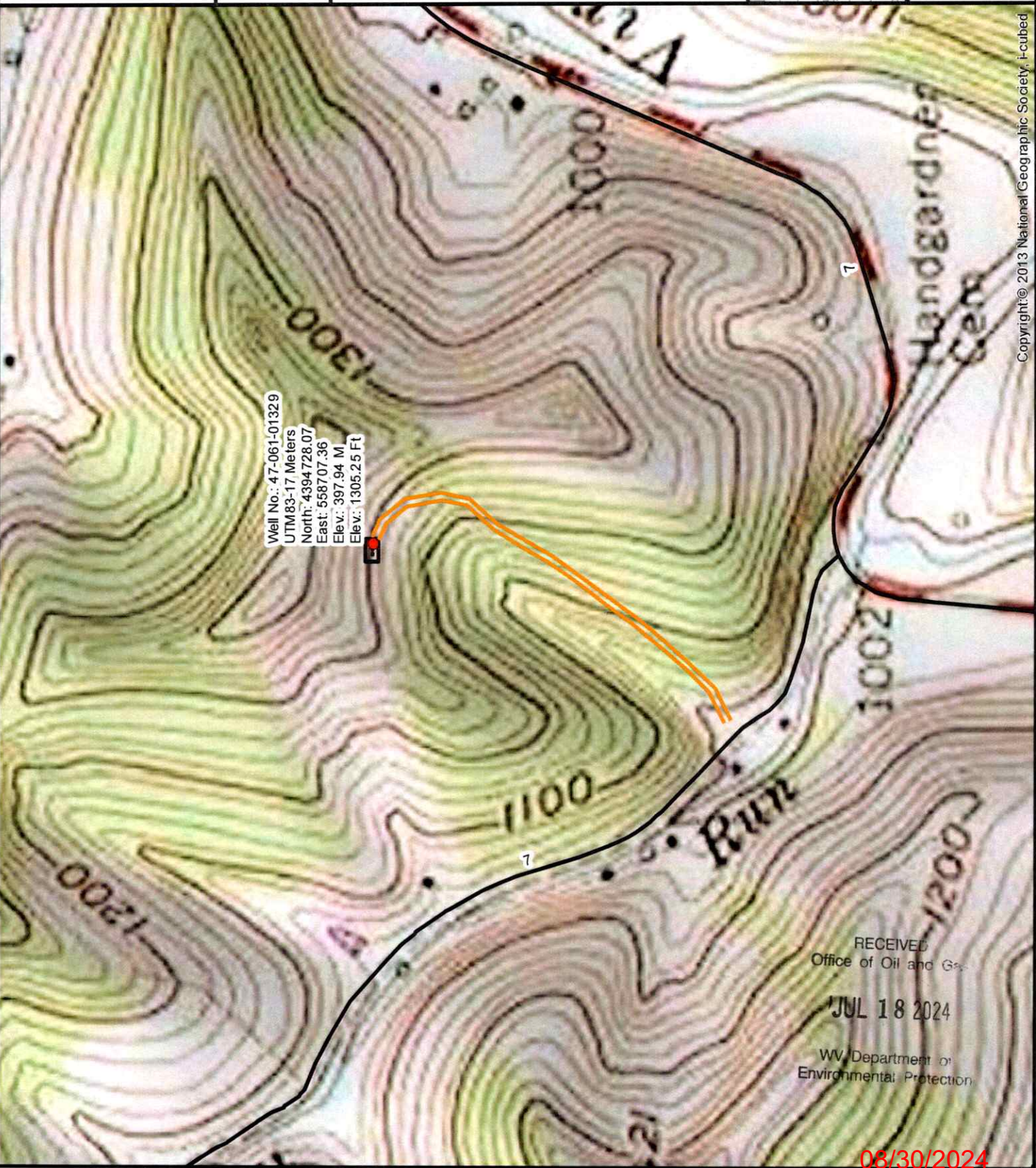
Well Plugging Map

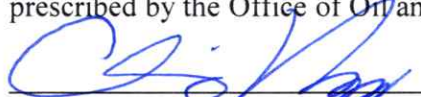
