Notification shall be given by the operator to the Oil and Gas Inspector at least 24 hours prior to the construction of roads, locations, and/or pits for any permitted work. In addition, the well operator shall notify the same inspector 24 hours before any actual well work is commenced and prior to running and cementing casing. Spills or emergency discharges must be promptly reported by the operator to 1-800-642-3074 and to the Oil and Gas Inspector.

Please be advised that form WR-35, Well Operators Report of Well Work is to be submitted to this office within 90 days of completion of permitted well work, as should form WR-34 Discharge Monitoring Report within 30 days of discharge of pits, if applicable. Failure to abide by all statutory and regulatory provisions governing all duties and operations hereunder may result in suspension or revocation of this permit and, in addition, may result in civil and/or criminal penalties being imposed upon the operators.

- 1. All pits must be lined with a minimum of 20 mil thickness synthetic liner.
- 2. In the event of an accident or explosion causing loss of life or serious personal injury in or about the well or while working on the well, the well operator or its contractor shall give notice, stating the particulars of the accident or explosion, to the oil and gas inspector and the Chief within twenty-four (24) hours.
- 3. Well work activities shall not constitute a hazard to the safety of persons.

- 1. MIRU Service rig, pull rods and tubing out of hole (if any), clean hole to TD
- 2. Run 2 3/8 8rd tubing to a minimum of 50' below the producing pay zone, pump and set cement plug using Class A cement to a minimum of 50' above the producing pay zone, pump 6% gel ahead of cement. (Minimum 100' bottom plug)
- 3. Tag cement top to ensure plug meets minimum, add cement if necessary. Find free point on casing, cut and remove casing and pull out of hole.
- 4. Run 2 3/8 8rd tubing to a minimum of 50' below the cut casing. Pump and set cement plug using Class A Cement to a minimum of 50 above cut casing, pump 6% gel ahead of cement. (Minimum of 100' casing cut plug)
- 5. Tag cement top to ensure plug meets minimum, add cement if necessary.
- 6. Pull and set 2 3/8 8rd tubing a minimum of 50' below elevation depth. Pump and set cement plug with Class A Cement to a minimum of 50' above elevation depth, pump 6% gel ahead of cement. (Minimum 100' elevation plug)
- 7. Tag cement top to ensure plug meets minimum, add cement if necessary.
- 8. Pull and set 2 3/8 8rd tubing to a minimum of 100' below surface, pump Class A cement to surface. (Minimum 100' surface and fresh water strata plug)
- 9. Erect 3' x 6" with identification and fill with cement.
- 10. RDMO service rig, all surface equipment and disposals.
- 11. Reclaim location and lease road.
- 12. Prepare release forms.

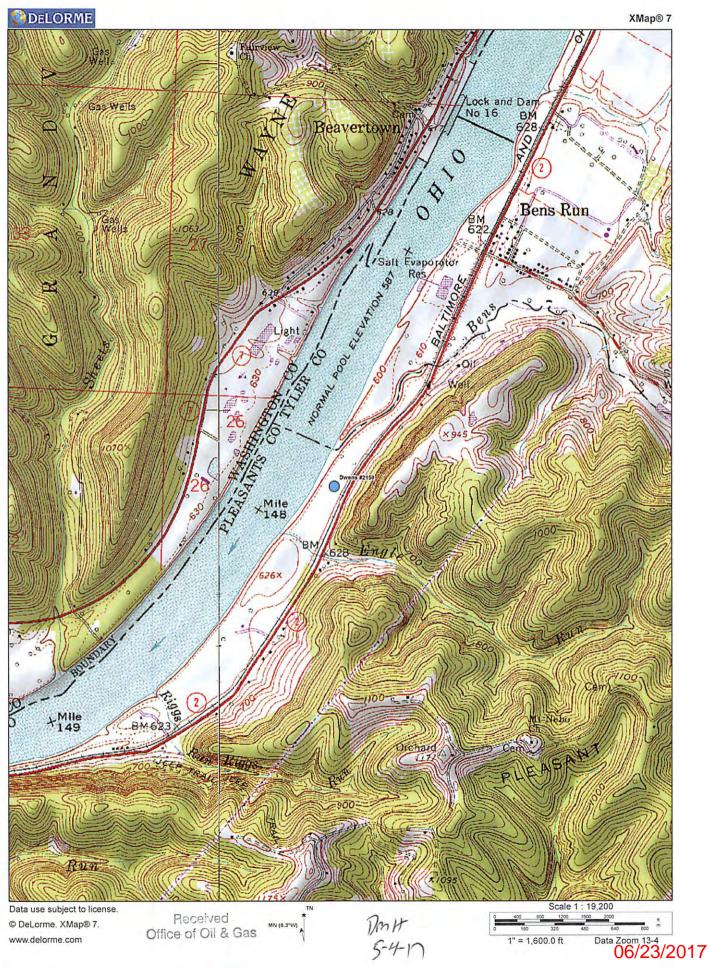
