

north by a small stream and has been ditched for drainage along the south boundary at the base of a cut bank. The entire area has been covered with limestone. The cut bank and stream banks

have been seeded and are now grass covered. The pit for the well will be a portable steel tank When the well is completed, the tank and cuttings will be removed, and the area reclaimed, and limestone replaced wherever disturbed by the drilling operation. The grass covered banks should not be disturbed, but if so, they will be reseeded.


