Joe Sommerville and Tim Simmons, being first duly sworn according to law depose and say that they are experienced in the work of plugging and filling oil and gas wells and were employed by CNX Gas Company, LLC, Well Operator, and participated in the work of plugging and filling the above well, that said work was commenced on 12-16-14, and that the well was plugged in the following manner:

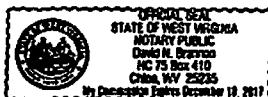
