19) Describe proposed well work, including the drilling and plugging back of any pilot hole:

This well has been drilled to a TMD of 7,134'. Continue drilling and complete a new horizontal well in the Marcellus Formation. Finish drilling the curve. Drill the lateral in the Marcellus. Cement casing.

20) Describe fracturing/stimulating methods in detail, including anticipated max pressure and max rate:

Hydraulic fracturing is completed in accordance with state regulations using water recycled from previously fractured wells and obtained from freshwater sources. This water is mixed with sand and a small percentage (less than 0.1%) of chemicals (including 15% Hydrochloric acid, friction reducer, biocide, and scale inhibitor), referred to in the industry as a "slickwater" completion. Maximum anticipated internal casing pressure is expected to be approximately 10,000 psi, maximum anticipated treating rates are expected to average approximately 100 bpm. Stage lengths vary from 150 to 300 feet. Average approximately 350,000 gallons of water per stage. Sand sizes vary from 100 mesh to 20/40 mesh. Average approximately 200,000-600,000 pounds of proppant per stage.

Dear Mr. Hurst,

EQT Production Company ("EQT") hereby requests permission from Antero Resources Corporation ("Antero") to proceed with EQT's plans to drill one or more horizontal wells in, under, and through certain properties subject to oil and gas interests owned or controlled by Antero located in Wetzel County, West Virginia, as more particularly described on Exhibit A to this letter agreement (the "O&G Interests"), and insofar and only insofar as such O&G Interests are located within the Units (as defined below) and further insofar and only insofar as to the Target Rights (the "Properties"), pursuant to the terms and conditions of this letter agreement. Antero and EQT are currently parties to an Acreage Trade Agreement dated December 8, 2020 (as amended from time-to-time, the "Trade Agreement"), which includes the Properties. The closing of the Trade Agreement is scheduled to occur on or before June 17, 2021, subject to the term of the Trade Agreement. EQT desires to drill the Properties for EQT's units more particularly described on Exhibit B to this letter agreement (the "Units") prior to the Closing contemplated by the Trade Agreement. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Trade Agreement.

In order to generate mutual goodwill between EQT and Antero, and for one hundred dollars (\$100.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Antero hereby grants EQT the right to apply for and obtain all applicable governmental permits for the drilling of one or more wellbore laterals in, under, and through the Properties (collectively, "Wells") and to drill, complete and produce such Wells.

In the event that the Trade Agreement is terminated pursuant to its terms (or is not terminated but fails to Close with respect to all or any portion of the Properties), then EQT and Antero shall enter into one (1) or more mutually-agreed joint operating agreements (with each contract area covering a Unit) with respect to the Properties (or the portions thereof for which Closing failed to occur), effective as of the date hereof.

EQT hereby agrees to release, protect, indemnify, defend and hold harmless Antero from and against any claims, expenses, damages, injuries, claims or obligations or liabilities (including reasonable attorneys' fees) that may be brought by any third party against Antero or its Affiliates to the extent arising out of EQT's drilling or other operations pursuant to this letter agreement and that arise on or after the date of this letter agreement through the Expiration Date (as defined)

below). This paragraph shall survive (a) the Closing and the assignment or lease, as applicable, related to the Properties, (b) the execution of a mutually-agreed joint operating agreement with respect to any Properties, or (c) any termination of all or any part of this letter agreement.

Nothing in this letter agreement will diminish any current or future rights of Antero in the Properties or other properties. This letter agreement and the rights and obligations of EQT and Antero hereunder will terminate (on a Property-by-Property basis) upon the earlier of (I) the execution of a mutually-agreed joint operating agreement with respect to such Property or (II) if and when Antero and EQT consummate the Closing of the Trade Agreement with respect to such Property ("Expiration Date").

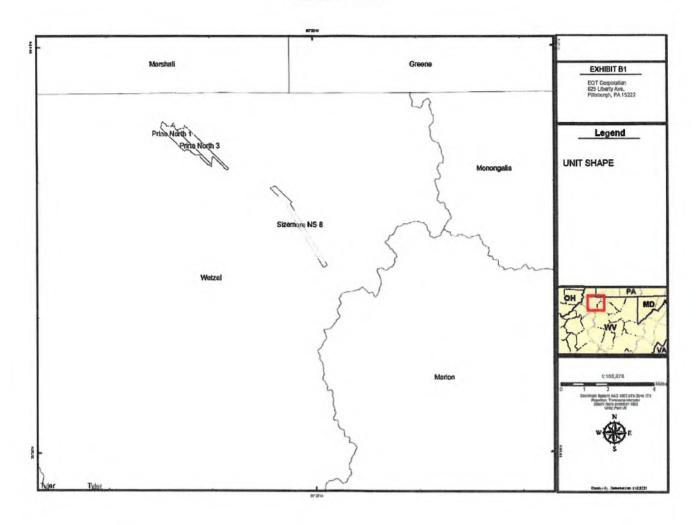

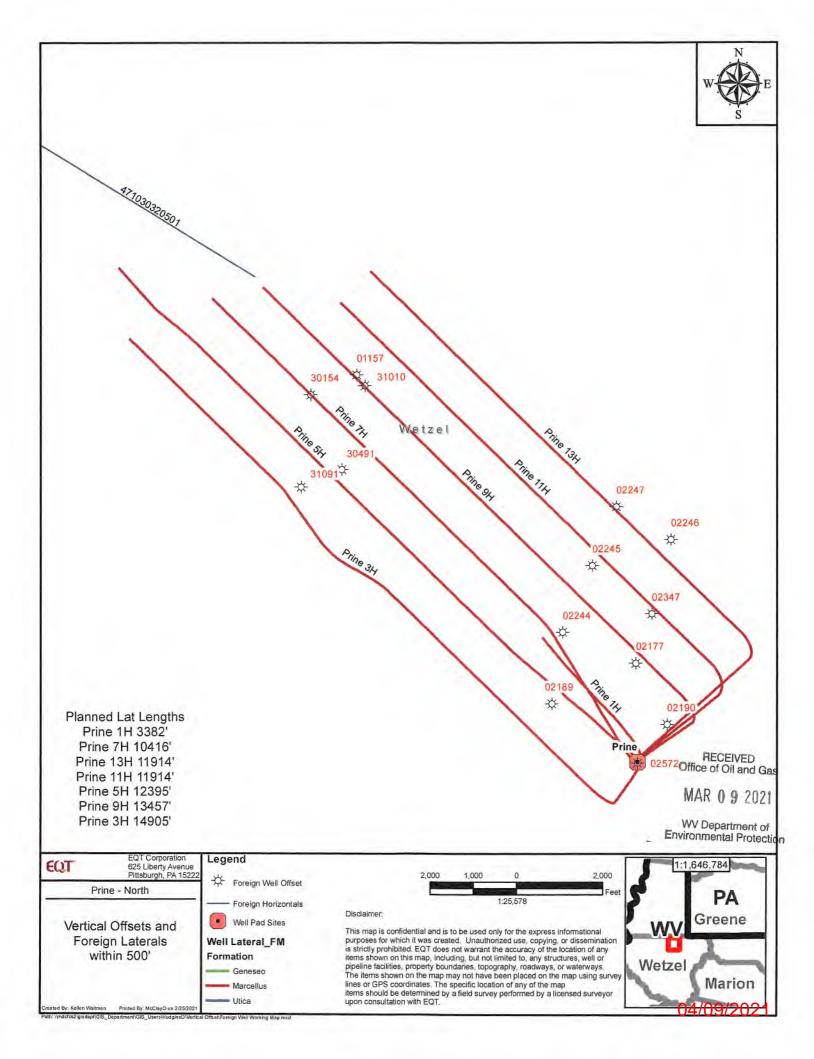
