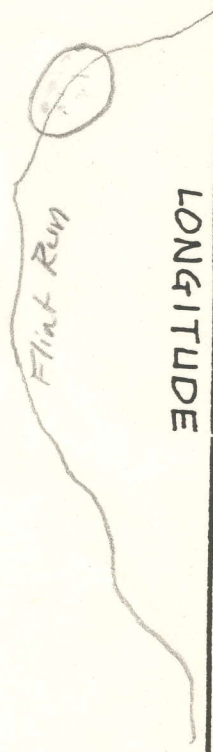

WELL LOCATION MAP

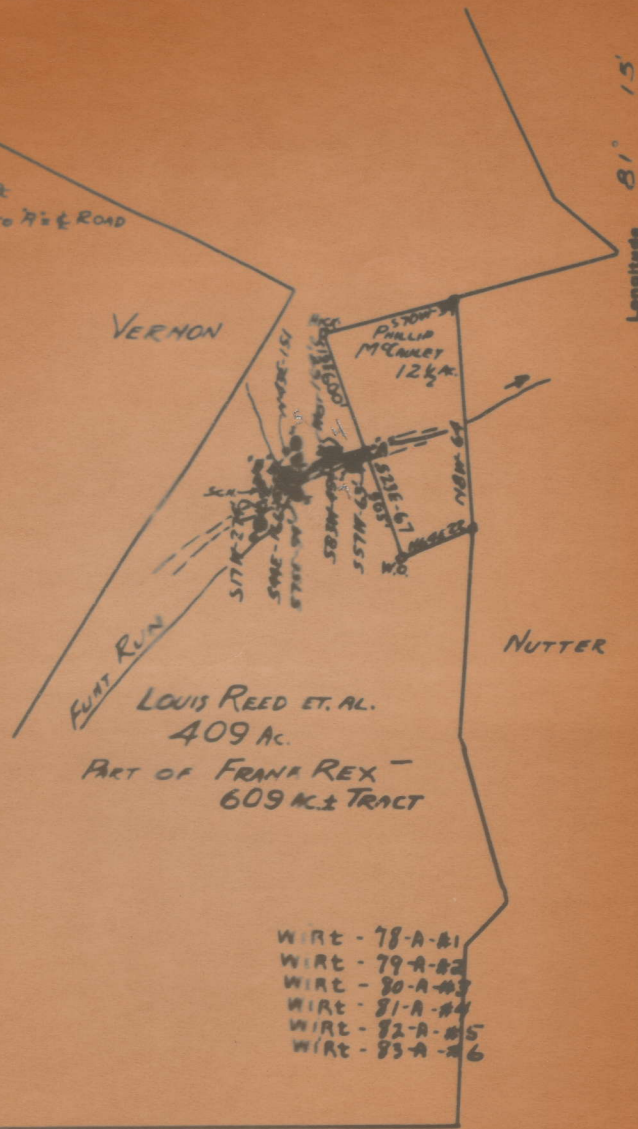
