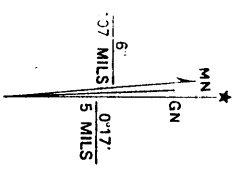

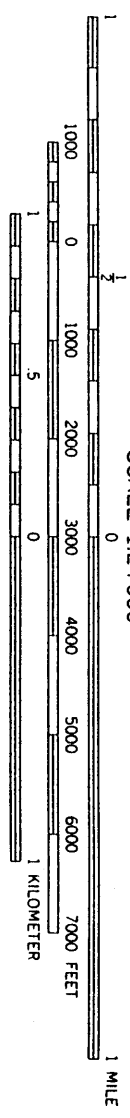
1987 MAGNETIC NORTH

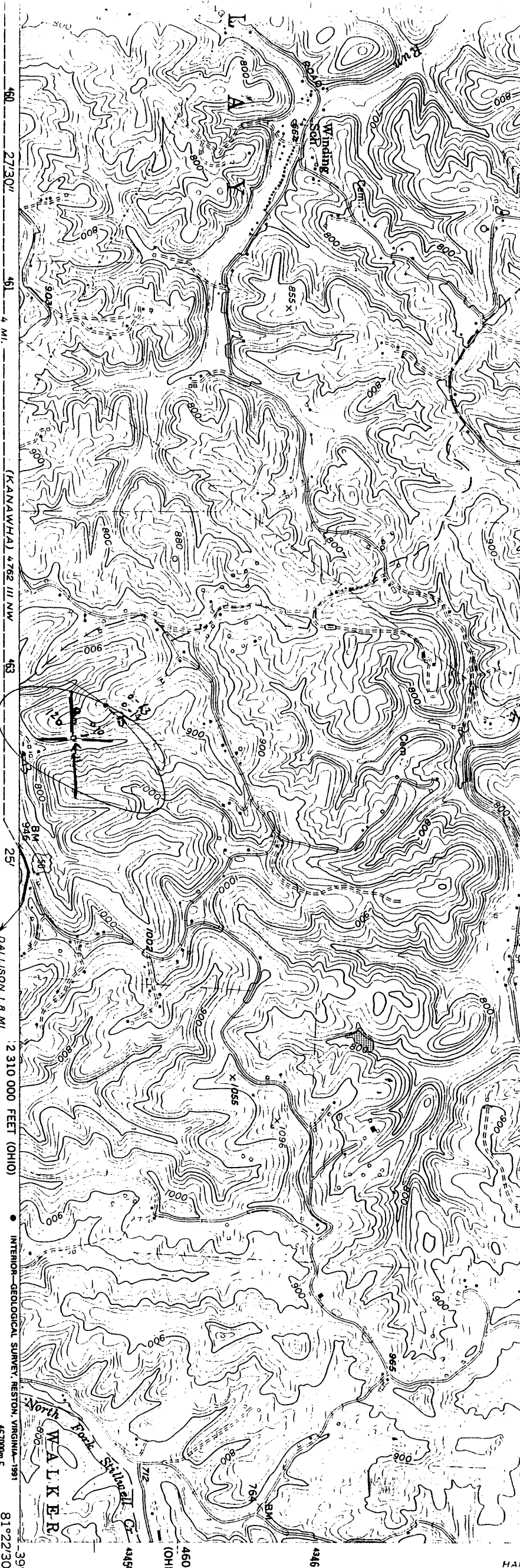
